



In conducting our audit, we became aware of an aspect concerning the Department's operations for which we believe corrective action is necessary. As a result, we have developed a recommendation which is reported on the following page. We believe you should be aware of this recommendation. This recommendation has been discussed with Department personnel and their response to the recommendation is included in this report. While we have expressed our conclusion on the Department's response, we did not audit the Department of Management's response and, accordingly, we express no opinion on it.

Report of Recommendations to the Department of Management

June 30, 2009

Findings Reported in the State's Report on Internal Control:

No matters were noted.

Other Findings Related to Internal Control:

Payroll – The Department processes and records payroll and personnel information on the Human Resource Information System (HRIS). The Human Resources Associate utilizes an online P-1 document to initiate and approve payroll transactions, such as adding new employees and recording pay raises.

The Department's standard practice is for an independent person to apply Department level approval on the P-1 document. However, two individuals have the ability to both initiate and approve P-1 documents.

Recommendation – To strengthen controls, the Department should develop and implement procedures to segregate the duties of the Human Resources Associate.

Response – On March 3, 2010, the new department director implemented internal staffing changes to further strengthen the Department of Management's personnel and payroll controls and, as a result, during the week of April 12, 2010, a process was put in place to segregate the two levels of approval in HRIS.

Conclusion – Response accepted.
